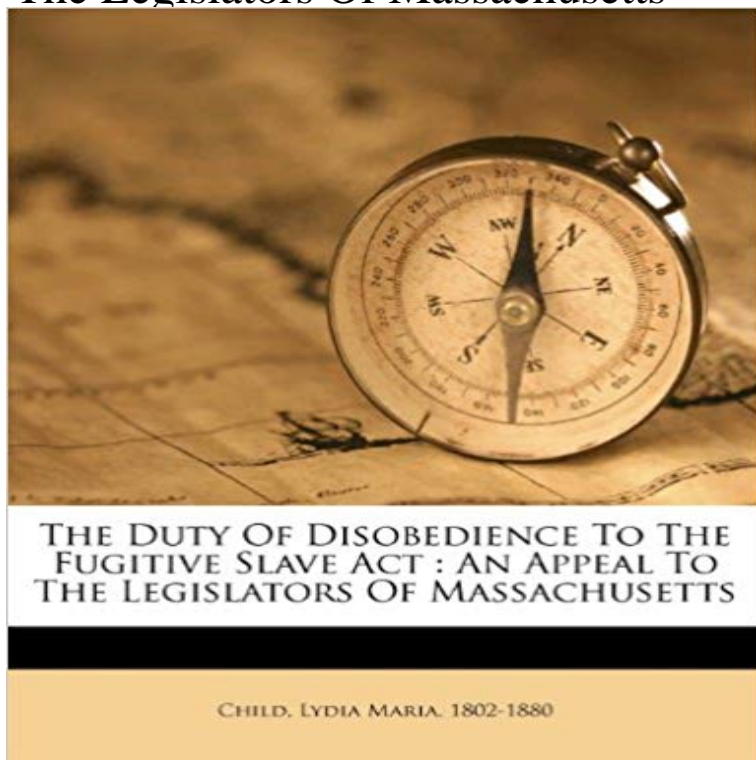


The Duty Of Disobedience To The Fugitive Slave Act: An Appeal To The Legislators Of Massachusetts
